

24th Austrian Ball: Rules of the dance courses

1. Safety policy for visits of OEGP, DSP and Zpevacky spolek Hlahol

This document sets out binding guidelines for persons who, with the consent of a responsible person, enter the premises of the OEGP (Österreichisches Gymnasium Prag), DSP (Deutsche Schule Prag) or ZSH (Zpevacky spolek Hlahol) for the purpose of participating in a dance course organised by Fortissimo Prague s.r.o. (hereinafter collectively referred to as 'course participant').

These are organizational measures taken to protect the life and health of the course participants as well as other persons who may be endangered by their actions, to protect the property of OEGP, DSP, ZSH and the environment.

Responsible person means an employee of Fortissimo Prague s.r.o. or a person authorised by such employee.

2. Instructions for course participants entering the OEGP, DSP, and ZSH buildings and for their stay in these buildings

- The course participants are forbidden to walk around the OEGP, DSP, and ZSH facilities alone. Course participants may only walk around when accompanied by a responsible person, unless the responsible person decides otherwise.
- The course participants are forbidden to leave the premises designated for the lessons or to separate from the group when walking around the OEGP, DSP, and ZSH facilities. If necessary (e.g., to use the restroom), course participants are required to report this to the responsible person.
- Running, rollerblading, scootering, or using other similar means of transport is prohibited in OEGP, DSP, and ZSH buildings.
- Animals are not allowed in OEGP, DSP, and ZSH buildings.
- Dangerous items are not allowed in OEGP, DSP, and ZSH buildings, including weapons, ammunition, or any part thereof, non-lethal weapons, stabbing, cutting, or striking weapons.
- Smoking, consumption of alcoholic beverages, and other addictive substances are prohibited in OEGP, DSP, and ZSH facilities. At the same time, it is prohibited to enter these facilities under the influence of such substances.
- Open flames are prohibited in OEGP, DSP, and ZSH facilities.
- Fire extinguishers are located in the corridors and it is strictly forbidden to misuse any of the firefighting equipment. In case of fire, the course participants should inform the responsible person immediately and follow her/his instructions when leaving the premises/building.



- In OEGP, DSP, and ZSH facilities, it is prohibited to touch, smell, or taste any chemical substances or samples without the permission of the responsible person.
- In OEGP, DSP, and ZSH facilities, it is prohibited to touch the inventory, technical
 equipment or appliances, manipulate with them or anyhow interfere with their
 operation.
- In OEGP, DSP, and ZSH facilities, it is also prohibited to climb ladders and enter areas that are more than 1.5 meters above the ground and where there is no protection against falling.
- The course participants are required to report any injury, accident, or damage to property (inkl. minor ones) that they have caused or witnessed to the responsible person.
- The course participants are required to keep the designated area tidy and clean and not to bring in any items other than those needed to perform the relevant activity.
- The course participants are required to follow all safety instructions given by the responsible person.
- The course participants are required to ensure their own safety and behave in a disciplined and considerate manner towards others.
- In the event of any unforeseen circumstances, course participants shall inform the responsible person and follow their instructions.

3. Basic rules of the dance course

The course participants are required to comply with the safety rules and instructions set out in articles 1. and 2. above.

The course participants acknowledge that if they violate any of the prohibitions set out in point 2 above, their participation in the dance course may be immediately terminated by the responsible person.

The deposit of CZK 2,500 for participation in the dance courses will be refunded to the participants within 14 days after the end of the Austrian Ball. In the event of more than two absences or a serious violation of the conditions of the dance courses, this deposit may be forfeited.

A deposit of CZK 3,500 for rented clothes will be refunded to the participants within 14 days after the end of the Austrian Ball against the returned clothes. The clothes must be professionally cleaned and returned together with the receipt issued by the dry-cleaning service.
